This release extends to any and all claims I have or later may have against the "Released Parties" resulting from or arising out of their performance of their organizational duties whether or not such claims result from negligence (except willful neglect) on the part of any or all of the "Released Parties" with respect to "The Patriot Tour" or with respect to the conditions, qualifications, instructions, rules, or procedures under which "The Patriot Tour" is conducted from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE "RELEASED PARTIES" FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH MY PARTICPATION IN THE "PATRIOT TOUR" OR AGAINST THE "RELEASED PARTIES."

I am experienced in and familiar with the operation of motorcycles and fully understand the risk and dangers inherent in motorcycling. I certify that I am not under the influence of any narcotic, alcohol or other drug that may impair my understanding or judgment and that I will not at any time during the event(s) operate my motorcycle under the influence of any narcotic, alcohol or drug. I certify that I have fully adequate insurance to cover all medical claims, the motorcycle and any other equipment and any damage or liability I may ultimately be found responsible for. I further certify that I have all the insurance required by law and I am licensed and competent to operate a motorcycle in a safe manner and my license has all motorcycle endorsements or certificates required by my state of residence.

I am voluntarily participating in "The Patriot Tour" and I expressly agree to assume the entire risk of my accidents or personal injury, including death, which I might sustain to my person or property as a result of my participation in "The Patriot Tour," and any negligence (except willful neglect) on the part of any and all of the "Released Parties" throughout "The Patriot Tour."

## WAIVER OF RIGHTS UNDER STATE STATUES

I further agree to waive all benefits flowing from any state statue which would negate or limit the scope of this release and Indemnification Agreement, including, but not limited to Section 1542 of the California Civil Code which provides:

*"A general release does not extend to the claims which the creditor does not know or suspect to exist in his or her favor at the time of executing this release, which if known to him or her must have materially affected his or her settlement with the debtor."*
